

MUSH PUPPIES SIBERIAN HUSKIES

LIMITED WARRANTY

1. Our warranty is for three years ONLY with a verifiable subscription to NuVet Plus supplements. We have started supplementing our pups with Nu Vet Plus. We have found it helps our dogs so much, that we will warranty to three years if the pups continue to be supplemented with Nu Vet Plus the entire three years. Nu Vet Plus can only be purchased from the company itself and for the guarantee to apply, you must use code 25117. It will record your purchase and we can verify it to maintain the warranty.
2. Your puppy is vet checked and vet vaccinated before going to their new homes.
3. Puppies will be up to date on vaccinations (Dhppc) that are appropriate for age.
4. Puppies will be de-wormed for intestinal parasites at approximately 2, 4 and 6 weeks of age.
5. Puppy must be examined by a licensed veterinarian within 72 hours of receipt for guarantee to apply. It is Buyer's responsibility to have puppy examined by a US licensed veterinarian of Buyer's choice within 72 hours of receipt of puppy to protect Buyer and Seller. Seller guarantees that puppy is free of life threatening diseases or disabilities for 72 hours after delivery to Buyer. Should life threatening diseases or disabilities be discovered by Buyer within 72 hours after receipt of puppy, and attested to in writing to Seller by Buyer's veterinarian, Seller will provide Buyer with a replacement breed quality puppy as soon as a puppy is available. If cause of death cannot be determined by a licensed vet to be from preexisting virus or disability, then a necropsy will need to be performed.
6. Vaccinations must be kept current by a licensed veterinarian and the puppy must receive treatment and preventative care for internal parasites. Puppies can be started on heart worm prevention after 8 weeks of age, but no later than 5 months of age. Buyer's vet will need to establish a heart worm prevention program.
7. Seller guarantees that puppy is in good health and has received appropriate medical inoculations and care including vaccination(s) and intestinal worming(s). Seller will provide Buyer with a medical chart and/or vet receipts detailing treatment puppy has received under Seller's care. Should, regardless of reason, the puppy selected becomes undeliverable before its pickup date, Seller will provide Buyer with a replacement breed quality puppy as soon as a puppy is available from another or future litter.
8. All puppies will be chipped with either an AVID, HOME AGAIN or HOME AGAIN TEMP SCAN microchip (Breeder's discretion) before going to their new homes, unless otherwise requested by Buyer. Buyer needs to register chip and will be supplied with application or on line directions for submitting application
9. Buyer will be given AKC application for their new puppy. Puppies are guaranteed to be from AKC bloodlines.
10. If within 12 months from birth, the puppy dies, a necropsy MUST be performed by a state or university veterinary pathologist and a report issued and provided to seller with cause of death. If the cause of death is genetically derived, money will not be refunded, but you will be given a replacement puppy of equal value as soon as one becomes available. The puppy is not to be interred until after a proper necropsy report is received.
11. Seller shall not be held responsible for the development of non-genetically derived diseases or disorders which are due to the Buyer's negligence.
12. Buyer must pay any shipping or miscellaneous charges associated with transport of Dog/Bitch and/or replacement puppy.
13. Buyer's is responsible for providing puppy with safe, comfortable, and adequate shelter at all times; along with quality food and fresh water.
14. Seller shall not be responsible for acts of puppy which are due to the Buyer's negligence.
15. Guarantee does **NOT** cover undescended testicles, fertility or infertility in males or females.

16. Seller, does not guarantee eyes, eye colors/shades, facial markings/masks/nose color, or coat colors/shades.
17. No other guarantee is given or implied.
18. Our puppies are only to reside in the continental United States, Alaska and Canada for the guarantee to apply. Our puppies are not to reside out of the contiguous United States, Alaska and Canada.
19. If puppy is younger than six weeks, Buyer agrees that payment balance of puppy will be paid by six weeks of age (43 days to include the date of birth) otherwise any monies paid towards the puppy can be forfeited and puppy can be relisted. After six weeks, full payment is due for puppy at time of reservation, unless otherwise arranged. It is not the responsibility of the Seller to call Buyer. If you cannot take possession of your pup or can no longer take care of it, we do not provide monetary refunds regardless of your reason for not taking possession or keeping your puppy.
20. Any legal matters must be presented within the County of St Clair, State of Illinois. Any legal fees and court costs shall be the responsibility of the Buyer if Buyer is found to be at fault.
21. Seller strongly recommends that Buyer attend obedience classes with puppy and provide proper socialization opportunities.
22. Seller recommends that buyer reads "The Critical Periods of Your Puppy's Life" and continue with proper training and socialization that is essential for proper development.
23. **Please Note: PUPPIES DO NOT HAVE FULL IMMUNITY UNTIL THEY RECEIVE THEIR ADULT ANNUAL VACCINATIONS AT APPROXIMATELY 4-5 MONTHS OF AGE.**
24. After a vaccine is administered, immunity is not immediate -it takes about five to ten days to become effective. However, puppies that still have maternal antibodies will not be affected by the vaccine. There is no way to be certain if a puppy still has maternal antibodies, hence the reason for boosters.
25. True immunity is uncertain until about four months of age when all puppy boosters are completed.
26. Avoid bringing your puppy to dog parks or otherwise exposing your puppy to unknown animals until all vaccinations have been given. Do not let it around other dogs, shoes, veterinary floors, grass areas, store floors (example: PetsMart, Petco, etc) or anywhere he may come into contact with a disease, until all puppy vaccinations are completed!
27. **Please Note:** Be aware when you go to your vet and ask about your puppy receiving Leptosia. It is an optional vaccine and up to the discretion of your vet, but we do not recommend Leptosia until the pups receive their Annual vaccinations, if needed. It is the responsibility of the Buyer to keep the puppy safe. Puppies need to stay in a controlled area, where they are not exposed to unknown viruses. Leptosia is for disease from the excrements of wild animals. Leptosia is a man made vaccine that contains large molecules, hard for a puppy's or small dog's system to absorb. Therefore, there is a chance for allergic reaction.

By submission of a puppy application, the Buyer agrees to all the terms set forth in this guarantee. If application is not submitted, then no guarantee is given nor implied to exist. No guarantee is given or implied to exist without a verifiable, current subscription to Nu Vet Plus supplements as stated in paragraph 1.
